1. **Apologies for absence** – apologies were received from Cllrs Snape, Waterhouse and Wilkinson.
2. **Declarations of Councillors' Interest and dispensations**

3. **To approve the minutes of the previous Parish Council meeting(9 January 2013)** – the minutes were approved.
4. **Matters arising –**
Fort Street garage site – the Parish Council have carried out a review of the garages on the Fort Street site and have noted any garages where there is no apparent vehicle usage or where the garage appears to used only for storage. The Clerk will detail these findings to John Gorton, Ribble Valley Borough Council.
5. **Public participation:**
3 members of the public attended the meeting.

7. Borough Councillor's Report – Borough Councillor John Hill brought to the attention of the Parish Council new legislation concerning the need for highways closure for community and church events such as Whit Sunday processions. This will now require a traffic management order from Lancashire County Council at a cost of £1,000. Councillor John Hill is hoping to highlight this problem as it could mean that village community events will become too costly to be viable. Councillor John Hill also highlighted Ribble Valley Borough Council's current policy and practice regarding planning application enquiries/responses. He will raise this issue with Ribble Valley Borough Council.

10. Playground:

- a) **To receive the monthly inspection report** – the new self-closure fitting on the gate is working well.
- b) **Repairs and maintenance** – there has been some vandalism to the new cradle swings. These have been refitted with anti-vandalism bolts.

a) **20 mph signs** – the signs are due to be put in place across the village indicating the new 20mph restrictions. One resident on George Lane has complained about the siting of one of the signs which is planned to be directly outside his window. The Parish Council have written to Lancashire County Council requesting that they reconsider the siting of this particular sign.

b) **Footpaths**

- the Parish Council have written to the landowner of Shady Walks requesting that he consider re-opening the concessionary footpath from Shady Walks to Back Lane. To date no reply has been received.
- The Lengthsman is looking into clearing the fallen tree in Gooseleach Wood.
- The annual survey of footpaths is due to take place. Councillors Pollard and Bennett will carry this out.

c) **War Memorial** - the Working Party (Councillor D Waterhouse, Clerk, Brian Jeffery and Peter Jackson) met on 2 February 2013 at the site to discuss the work required on the War Memorial. The Clerk had spoken to the Vicar who had given details of the required procedure. The Parish Council would need to seek permission from the Diocesan Advisory Committee to make any alterations to the War Memorial and also detail any plans for cleaning. The working party considered that if the cleaning quote used a simple jet wash cleaning method this work could be carried out by the Lengthsman. Also the area around the monument needs weeding and perhaps the limestone chippings renewed. This work might also be done by the Lengthmans. The carving of the 4 additional names was discussed but this issue will need specialist

advice from a stone mason if permission is granted from the Diocesan Advisory Committee for this work to be carried out.

d) Read Motor Body Lease – the Parish Council are waiting for the lease to be finalised by Pallisters. The site has become very untidy with rubbish dumped on the site.

RESOLVED: Councillors Pollard, Nichols, Mashiter and Bennett will meet with the owner of Read Motor Body Centre to attempt to resolve this issue.

e) Signs

- **George Lane fingerpost sign** – Councillor Pollard circulated an illustration of the proposed new fingerpost sign. A request has been made to Lancashire County Council for permission to make the changes.
- **Devil's Elbow sign** – the cast iron post was damaged recently in a road traffic accident. A quote of £25 has been obtained for the repair of the post.

RESOLVED: To have the post repaired at a cost of £25.

f) LCC Gritting Schedule – the Parish Council reviewed the designated secondary routes on the gritting schedule.

RESOLVED: To make a request to Lancashire County Council that Buckingham Drive, Berkeley Drive, Woodhead Road and Victoria Lodge be included in the gritting schedule.

g) Bus Shelter damage – there has been some vandalism to the Parish Council owned bus shelter on Whalley Road. One of the perspex sheets has been smashed.

RESOLVED: To purchase a new perspex sheet at a cost of £125 and for the Lengthsman to fit this.

h) Appointment of Internal Auditor

RESOLVED: To appoint G Lambert as internal auditor for 2013/2014.

3/2012/1101 The Whins, Whins Lane, Read BB12 7QY

Proposed demolition of the existing dwelling and redevelopment of the site for residential use including 16 homes.

Consultation expiry date 24/1/2013

Parish Council response:

Read Parish Council's meeting held on 9th January 2013 was attended by over 30 residents from both Read and Simonstone wishing to make known their objections to the above application.

Concerns centred mainly on the question of highway safety, creeping incursion into the countryside and the ability of the present infrastructure (sewerage, schools, highways) to sustain the development.

The Parish Council, mindful of RVBC's obligations under the Core Strategy to meet the housing demands necessary to address the current national housing shortage, accept that it is unrealistic to expect Read (or Simonstone) to be excluded from any future housing developments and believe that the siting of this development on the outer edge of the settlement area is preferable to previously suggested sites on Hammond Field and Whalley Road.

The Parish Council believe that the applicant has submitted a well thought out scheme, but would ask that before approval is given, further thought should be given to the concerns raised by local residents to assure them that the development meets the required planning and highway safety criteria.
